Dear Mr. Knecht:

In a recent court filing, Steven Gruel, counsel for Anthony Pellicano, alleges that Sandra Carradine acted as a "go-between" for him and Pellicano during Pellicano's incarceration at FCI Taft, and that she solicited Mr. Gruel's "thoughts, opinions and general observations about the government's case." Mr. Gruel further suggests that Ms. Carradine provided the government with information pertaining to his involvement in the case.

We made clear to you and to your client, in our initial meetings regarding cooperation, that Ms. Carradine was not to provide the government with any information concerning communications between Pellicano and his counsel. In his subsequent contacts with your client, Special Agent Ornellas specifically reminded her on more than one occasion not to provide him with any information concerning such communications. Further, to whatever extent Mr. Gruel might have shared his thoughts or client communications with Ms. Carradine, such information was never in fact communicated by her to the FBI or to this Office.

In light of Mr. Gruel's allegations, please consult with your client and promptly notify us in writing of whether she believes anything we have stated above is incorrect. In addition, please take the opportunity once again to impress upon your client that, to whatever extent she may be in possession of attorney-client information provided to her by Mr. Gruel or any of Pe.llicano's prior attorneys, she is not to disclose that information to any member of the prosecutive or investigative teams in this case.


